Do You Know?

<u>Taylor Law</u>: The Public Employees Fair Employment Act that passed in 1967 oversees public employee labor relations in New York State. This law permits union organizing and provides a system within which to resolve labor-management conflict short of striking. Public employers are required to recognize and negotiate in good faith with the union representatives of a bargaining unit.

<u>Triborough Amendment</u>: An amendment to the Taylor Law that provides that all terms, conditions and provisions of an expired public contract remain in effect until a new contract is approved.

<u>Collective Bargaining</u>: The contractual agreement between an employer and a labor union that governs wages, and working conditions for employees and which <u>can be enforced against both the employer and the union for failure to comply with its terms.</u>
